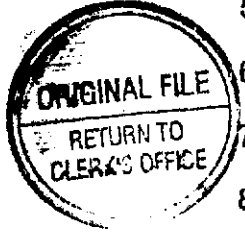


**AMENDED REQUEST FOR FILING OF TRANSCRIPT
